



## Participant Health Screening

1. Have you experienced a fever of 100.4 degrees F or greater, a new cough, shortness of breath, fatigue, muscle ache, or other unexplained symptoms within the past 10 days?  
 No. Go to the next question.       Yes. No further screening is needed. The scout may not participate.
2. Have you travelled outside of NY in the past two weeks or spent more than 24 hours within one of the designated states that has significant community spread?  
 No. Go to the next question.       Yes. List State / area below, further screening is needed.
3. In the past 10 days, have you gotten a positive result from a COVID-19 test that tested saliva or used a nose or throat swab? (not a blood test)  
 No. Go to the next question.       Yes. No further screening is needed. The scout may not participate.
4. To the best of your knowledge, in the past 14 days, have you been in close contact (within 6 feet for at least 10 minutes) with anyone while they had COVID-19?  
 No. The scout may participate.       Yes. No further screening is needed. The scout may not participate.

## Participant Requirements

Participants will be regularly reminded about face cover and social distancing requirements

- All Participants will be required to wear a face covering within six feet of distance from other individuals; or in a situation or setting where they are unable to maintain six feet of distance from other individuals.
- Participants are not allowed to share personal items such as water bottles, food containers or utensils.
- Participants should wash or sanitize hands before consuming food.

## Liability Waiver

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Tay House Troop 19 activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Tay House Troop 19 Activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Tay House Troop 19 volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at a TAY HOUSE TROOP 19 Activity ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Boy Scouts of America, Seneca Waterways Council, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the TAY HOUSE TROOP 19, its volunteers, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Tay House Troop 19 program.
